## Sitting Service Liability Release, Waiver, Discharge and Covenant Not to Sue

This is a legally binding Release, Waiver, Discharge and Covenant Not to Sue (collectively, the "Release"), made voluntarily by me, the undersigned Releasor, on my own behalf, and on behalf of my child(ren), pet(s), heirs, executors, administrators, legal representatives and assigns (hereinafter collectively, "Releasor," "I" or "me," which terms shall also include my child(ren)'s or pet(s) other parent, guardian, or owner, if Releasor is under 18 years of age) to Care 4 Kids, LLC, a Colorado limited liability company ("Care 4 Kids").
