I am aware that any cancellation made within 48 hours of the start time will incur full charge. I agree to pay for the full amount of time booked, even if I return early. I accept there is a 4-hour minimum charge on each booking

**Sitting Service  
Liability Release, Waiver, Discharge and Covenant Not to Sue**

This is a legally binding Release, Waiver, Discharge and Covenant Not to Sue (collectively, the "Release"), made voluntarily by me, the undersigned Releasor, on my own behalf, and on behalf of my child(ren), pet(s), heirs, executors, administrators, legal representatives and assigns (hereinafter collectively, "Releasor," "I" or "me," which terms shall also include my child(ren)'s or pet(s) other parent, guardian, or owner, if Releasor is under 18 years of age) to Care 4 Kids, LLC, a Colorado limited liability company ("Care 4 Kids").

As the undersigned Releasor, I fully recognize that there are dangers and risks to which my child(ren) or pet(s) may be exposed to, by participating in the sitting services provided by Care 4 Kids (the "Service"). As the undersigned Releasor, I understand that Care 4 Kids does not require me to enlist these Services, but I want to do so despite the possible dangers and risks and despite this Release. With informed consent, and for valuable consideration received, including assistance provided by Care 4 Kids, as the undersigned Releasor, I agree to assume and take on myself all of the risks and responsibilities in any way arising from or associated with this Service, and I release Care 4 Kids and all of its sitters, owners, officers, members, employees, agents, instructors, assigns and contractors (collectively, "Releasees"), from any and all claims, demands, suits, judgments, damages, actions and liabilities of every name and nature whatsoever, whenever occurring, whether known or unknown, contingent or fixed, at law or in equity, that I or my child(ren), pet(s) may suffer at any time arising from or in connection with the Service, including any injury or harm to me or my child(ren), pet(s) or damage to my property (collectively, "Liabilities") excluding any claims that cannot be legally waived or released, and I agree to defend, indemnify, and save Releasees harmless from and against any and all Liabilities.

As the undersigned Releasor, I recognize that this Release means I am giving up, among other things, all rights to sue Releasees for injuries, damages or losses I may incur. I also understand that this Release binds my heirs, executors, administrators, legal representatives and assigns, as well as myself. I also affirm that I have adequate medical or health insurance to cover any medical assistance I may require.

I agree that this Release shall be governed for all purposes by Colorado law, without regard to such law on choice of law.

I have read this entire Release. I fully understand the entire Release and acknowledge that I have had the opportunity to review this Release with an attorney of my choosing if I so desire, and I agree to be legally bound by the Release.
